Santol, La Union: "One People, One Town"

Directo of Lettac Norte, Santol, La Union on the new program established by the Municipal Government of Santol, La Union headed by Mayor Daisy Sayangda-Olivar.

The Santol Development Center (SDC) is set up to cater to the needs of the local residents on savings and investments. Through Sangguniang Bayan Resolution No. 2010-71, the center is established and operated by the Local Government Unit which will work as its corporate entity in providing revenues and as the main financial facility. It has an initial fund capital of three million pesos coming from the Presidential Challenge Fund (PCF) of the Department of the Interior and Local Government and RA 7171 Municipal Share of one and two million pesos, respectively. Recently, Congressman Victor C. Ortega contributed one million pesos from his RA 7171 share.

The SDC fosters a culture of thriftiness and self sustenance where the people are taught to imbibe the qualities of initiative and hardwork. According to Mayor Olivar, SDC is one of the answers to poverty alleviation and betterment of the quality of life of every Santolian.

There are four program services that the center is offering to the different walks of life of the Santolian. "Toy Agserbi Salary Loan" is extended to municipal & barangay officials and municipal employees. As of May 31, 2011, the SDC has approved applications amounting to P3,424,800.00. The "agNEGOSYO LOAN" is the second service program. Because of the closure of the only bank in the municipality, micro businessmen had difficulty seeking initial funds for their enterprise. With the establishment of the center, small-time entrepreneurs can avail of loans with very minimal interest rate of 8% per annum. Seventy one applications totaling to P498,945.02 were already approved as of May 31. "Plant Now

Pay Later" Scheme now renamed "magSIMULA LOAN" is a window of farmers. The municipal management acknowledges that capital is most essential in the production and the most pressing encountered by farmers. Thus they opened a loan opportunity for them. More than 200 farmers were provided with assistance with an amount of not less than 1.3 million pesos given. The last component "Kailian the Loan". This Ioan facility caters Overseas Filipino Workers and its families only.

With only seven months in operation, the four million pesos capital they have has ballooned to P6,186,622.95. If the prevailing trend continues and excellence and transparency in operations are practiced as what the Seal of Good Housekeeping advocates,truly the Santol Development Center is "Kadwam ti Asenso"! 

22 LGUs visit Dagupan City's CBDRRM

Lingayen, Pangasinan – Representatives from 22 local government units (LGUs) from Regions 1, 2, 3, 6, 10 and 11 participated in the field and exposure visit to Dagupan City, Pangasinan. The activity is part of the Department of the Interior and Local Government's (DILG) "Enhancing the LGU Capacity on Climate Change Adaptation and Disaster Risk" Project.

The said local government units (LGUs), the pilot targets for the project, went to Mangin, Central West and Pugaru, three disaster-prone barangays of the city. Dagupan City is one of the showcase cities on Community-Based Disaster Risk Reduction and Management (CBDRRM) and Early Warning System (EWS).

On the same occasion, DILG's Bureau of Local Government Development (BLGD) discussed the pertinent laws of Climate Change Adaptation (CCA) and Disaster Risk Reduction Management (DRRM). Candon City adopts DILG's CBMS the 2nd time around

As part of its efforts to update database for planning and targeting specifically on health, education and livelihood assistance. monitoring and Millennium Development Goals (MDG) accomplishments, the City Government of Candon, Ilocos Sur has adopted the Community Based Monitoring System (CBMS) of the Department of the Interior and Local Government (DILG) for the second time around.

The city implemented the program in 2006 and served as basis in prioritizing programs for the poorest of the poor and at the same time used as baseline data for the MDGs of the city.

A total amount of PhP 500,000.00 was appropriated for this year's implementation. Initially, day care workers and secretaries of the 42 barangays of Candon were already trained on the CBMS Module 1 -Gathering Tool - Household Survey Questionnaires. The city is also considering the involvement of Barangay Health Workers to fast track accomplishment of said Module. LGOO VI Mila P. and LG00 Ш Joselito C. CBMS DILG Ilocos Sur Focal Persons, served as the resource speakers. The city has already started the reproduction of the survey questionnaires, an estimated 12, 437 households will respond to.

DILG and KBP team up for the National Greening Program

The goal of NGP is to plant 1.5 million hectares of land with 1.5 billion seedlings from 2011 to 2016.

Carasi, IN empowers Indigenous Peoples:

Reps take seats in the Brgy. & Mun'l. Legislative Councils

The Municipality of Carasi, Ilocos Norte, headed by Mayor Joy Bannagui Fernandez, with the support of the elders of the Indigenous Cultural Communities (ICCs), has chosen the representatives of the Indigenous Peoples (IPs) representatives to the barangay and municipal legislative councils.

This is in compliance to the Indigenous Peoples Rights Act of 1997 or Republic Act No. 8371. The Department of the Interior and Local Government (DILG) and the National Commission of Indigenous People (NCIP) assisted the municipality in the realization of said endeavor.

RA 8371 provides for the mandatory representation policy IPs in the making bodies and legislative councils of local government units with ICCs. The law expressly granted same rights the indigenous communities for fully participate the decision The process in all levels. Local making Government Code of 1991 also supports mandates sectoral representation in the Sanggunian, which includes the ICCs. (LGOO II CHARIS O. GARMA, DILG Ilocos Norte)
