Know all men by these presents:

This CONTRACT is entered into by and between LA PATRICIA HOTEL represented by MS. ANGELICA BUEN-REVITA, Manager with business address at Beachfront, Barangay Sabang, Baler Aurora herein referred to as the FIRST PARTY.

THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT REGION 1, represented by DIR. JAMES F. FADRILAN, CESO III, Regional Director, with office address at Sevilla, City of San Fernando, La Union, herein referred to as the SECOND PARTY,

Under the following terms and conditions:

- 1.) That the FIRST PARTY will provide meals, snacks and accommodation for the SECOND PARTY'S participants for the conduct of Joint LGRRC Team and MSAC 1st Quarter 2019 Conference scheduled on March 15-16, 2019.
- 2.) That both parties agreed that the guaranteed number of participants is Forty Two (42).
- 3.) That the SECOND PARTY shall pay the contract price of Two Hundred Twelve Thousand Three Hundred Pesos (Php 212,300.00) of the scheduled conduct of the activity:

- 4.) That extra meals, orders and extension of stay or accommodation shall be billed based on actual head count in excess of the guaranteed number of participants.
- That any extension of stay shall be made at least one (1) day before occupancy and shall be 5.) billed separately.
