CONTRACT OF SERVICES

KNOW ALL MEN BY THESE PRESENTS:

This **CONTRACT OF SERVICE** is made and entered into this $\underline{|7^{+h}|}$ day of May, 2019 in the City of San Fernando, La Union, Philippines, by and between:

The **DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT REGIONAL OFFICE** 1, represented herein by **DIR. JAMES F. FADRILAN, CESO III, Regional Director**, with office and postal address at Aguila Road, Sevilla Norte, City of San Fernando, la Union 2500, herein referred to as the **First Party**.

That **SAN JUAN RESORT DEVELOPMENT AND MANAGEMENT CORPORATION** represented herein by **MS. CORNELIA G. SANCHEZ, Authorized Representative** with office address at Ili Sur, San Juan, La Union, herein referred to as the **Second Party**.

WITNESSETH:

WHEREAS, The FIRST PARTY will conduct "2019 SGLG Online Data Encoding" on May 22-24 and May 27-28, 2019 at San Juan Resort Development and Management Corporation;

WHEREAS, the SECOND PARTY has the capability to provide accommodation for the said activity that shall involve **fifteen (15)** live-in participants;

NOW, THEREFORE, for and inconsideration of the foregoing premises, the parties hereto agree on the following terms and conditions, to wit:

- THAT, the SECOND PARTY agrees and binds itself to the FIRST PARTY to provide accommodation for fifteen (15) live-in participants at the rate of Php 650.00 per pax/day for five (5) days with a total contract package of FORTY EIGHT THOUSAND SEVEN HUNDRED FIFTY PESOS ONLY (Php 48,750.00);
- 2. THAT, this Contract of Services shall be guaranteed for a minimum of seventy-five percent (75%) of the total number of target participants. If the attendance is above minimum, the SECOND PARTY shall provide accommodation at the same rate for the additional participants. If attendance is below the guaranteed minimum, the FIRST PARTY shall pay the SECOND PARTY the amount corresponding to the guaranteed minimum number of participants;
- 3. **THAT,** the payment of the amount due and payable under this Contract shall be based on the approved and funded activity design, subject to the established government accounting and auditing rules and regulations;
- 4. THAT, the SECOND PARTY guarantees to provide safe and clean accommodation to the FIRST PARTY, and the latter reserves the right to question any action of, or institute an appropriate action in the proper proceeding against the SECOND PARTY

for any injury that the **FIRST PARTY** may sustain from the services of the **SECOND PARTY**;

- 5. **THAT,** in case the **SECOND PARTY** failed to effect deliveries of what is stipulated herein, without any fault on the part of the **FIRST PARTY**, or was not due to fortuitous event, the contract will be automatically rescinded without going to court, and the **FIRST PARTY** shall be freed from any liability to the **SECOND PARTY**;
- 6. **THAT**, this Contract of Services shall be binding upon the parties but may be amended or cancelled/pre-terminated at the option of either party upon written notice of at least five (5) days before the commencement of the activity.
- 7. THAT, this Contract of Services shall take effect upon signature of both parties.
