

CONTRACT OF SERVICES

KNOW ALL MEN BY THESE PRESENTS:

This **CONTRACT OF SERVICE** is made and entered into this 15th day of April 2024 in the City of San Fernando, La Union, Philippines, by and between

The **DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT REGIONAL OFFICE 1**, represented herein by **JONATHAN PAUL M. LEUSEN, JR., CESO III - Regional Director**, with office and postal address at Aguila Road, Sevilla Norte, City of San Fernando, La Union 2500, herein referred to as the **First Party**

- and -

The **YNAD'S PLACE HOTEL AND RESORT, INC.**, represented herein by **REYNALYN BALANON-ALMOJUELA** with office address at By-Pass Road Barangay Namtutan, City of San Fernando, La Union, herein referred to as the **Second Party**.

WITNESSETH:

WHEREAS, the **FIRST PARTY** will conduct a two (2) days activity entitled "Conduct of Regional Institutional Development Support (RIDS) Program-Orientation on the SGLG Performance Indicator on LGU Inland Wetlands Conservation and Water Quality Management on May 16-17, 2024 at Ynad's Place Hotel and Resort, Inc., By-Pass Road Barangay Namtutan, City of San Fernando, La Union;

WHEREAS, the **SECOND PARTY** has the capability of providing food and accommodation for the conduct of the above-mentioned activity at reasonable cost;

NOW, THEREFORE, for and inconsideration of the foregoing premises the parties hereto agree on the contents of this Contract to wit:

1. **THAT** the **SECOND PARTY** agrees and binds itself to the **FIRST PARTY** to provide food and accommodation for the participants who will attend the "Conduct of Regional Institutional Development Support (RIDS) Program - Orientation on the SGLG Performance Indicator on LGU Inland Wetlands Conservation and Water Quality Management" to be held on May 16-17, 2024 at Ynad's Place Hotel and Resort, Inc., By-Pass Road Barangay Namtutan, City of San Fernando, La Union, with the contract package of ONE HUNDRED EIGHTY SEVEN THOUSAND FIVE HUNDRED PESOS ONLY (Php 187,500.00) as indicated in the approved activity design subject to the qualification that only the actual cost/billing of the **SECOND PARTY** shall be paid by the **FIRST PARTY** as appearing in the Statement of Account;
2. **THAT** this Contract of Services shall be guaranteed for a minimum of 75% of the total number of participants. If attendance is above minimum, the **SECOND PARTY** shall provide food and accommodation at the same rate for the additional participants;



3. In case of the unforeseen incidental expenses incurred by the **FIRST PARTY**, the **FIRST PARTY** shall pay the **SECOND PARTY** the amount corresponding to it;
4. **THAT** if the total number of participants exceed the foregoing guaranteed minimum number of participants, the **FIRST PARTY** shall pay the **SECOND PARTY** additional charges which shall be based on the actual number of participants at the indicated rate per person as indicated in Item #2 of this contract;
5. **THAT** the payment of the amount due and payable under this contract and the conduct of this activity is based on the approved and signed program/activity design subject to the usual government accounting and auditing rules and regulations;
6. **THAT** the **SECOND PARTY** guarantees to provide safe and clean food for the said activity to be conducted by the **FIRST PARTY**, and the latter reserves the right to question any action of, or institute any appropriate action in a proper proceeding against the former for any injury the **FIRST PARTY** may sustain resulting from any harmful or contaminated food served by the **SECOND PARTY**;
7. **THAT** in case the **SECOND PARTY** failed to effect deliveries of what is stipulated herein, without any fault on the part of the **FIRST PARTY**, or was not due to fortuitous event, the contract will be automatically rescinded without going to court and the **FIRST PARTY** shall be freed from any liability to the **SECOND PARTY**;
8. **THAT** this contract shall be binding and may be cancelled/terminated at the option of either party upon prior written notice at least five (5) days before the commencement of the activity;
9. **THAT** this Contract shall take effect upon signing of both parties concerned.

DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING ^{THE} SAME TO THE HOPE TO AWARD THE CONTRACT FOR THE LEASE OF VENUE AND HOTEL ACCOMMODATION INCLUSIVE OF MEALS AND SNACKS FOR THE CONDUCT OF REGIONAL INSTITUTIONAL DEVELOPMENT SUPPORT (RIDS) PROGRAM-ORIENTATION ON THE SGLG PERFORMANCE INDICATOR ON LGU INLAND WETLANDS CONSERVATION AND WATER QUALITY MANAGEMENT

WHEREAS, the Bids and Awards Committee (BAC) of the DILG Regional Office 1 adheres to the principles of transparency and competitiveness as mandated under RA 9184 otherwise known as "Government Procurement Reform Act" and its Revised Implementing Rules and Regulations;

WHEREAS, the Procuring Entity intends to Lease a Venue and Hotel Accommodation inclusive of Meals and Snacks for the conduct of REGIONAL INSTITUTIONAL DEVELOPMENT SUPPORT (RIDS) PROGRAM-ORIENTATION ON THE SGLG PERFORMANCE INDICATOR ON LGU INLAND WETLANDS CONSERVATION AND WATER QUALITY MANAGEMENT on May 16-17, 2024 with an Approved Budget for the Contract (ABC) of Two Hundred Two Thousand Five Hundred Pesos (Php 202,500.00);

WHEREAS, the BAC implemented the procedures prescribed for the Negotiated Procurement - Lease of Real Property and Venue for the aforesaid activity under Section 53.10 of the Revised Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, the BAC scheduled the opening of bids on May 8, 2024, 02:01 PM, with three (3) prospective Service Providers, namely: 1) Ynad's Place Hotel and Restaurant, 2) Awesome Hotel 3) Janpac Realty and Development. However, only Ynad's Place Resort and Hotel has submitted complete eligibility requirements with a total bid proposal of One Hundred Eighty-Seven Thousand Five Hundred Pesos (Php 187,500.00);

WHEREAS, after a thorough review and evaluation of the BAC assisted by the Technical Working Group, YNAD'S PLACE RESORT AND HOTEL was determined to be responsive to the technical requirements having obtained an overall rating of 99.5% which is above the DILG R1 prescribed passing rate of 85% for the lease of venue;

NOW THEREFORE, WE, the BAC Members, RESOLVE, as it is hereby RESOLVED:

- a) To declare Ynad's Place Resort and Hotel as the Single Calculated and Responsive Bidder (SCRB) with a bid amount of One Hundred Eighty-Seven Thousand Five Hundred Pesos (Php 187,500.00);
- b) To recommend to the HOPE the approval of this recommendation and to award the Contract for Lease of Venue to the SCRB.

Resolved, to furnish the Local Government and Monitoring and Evaluation Division (LGMED) and Finance and Administrative Division (FAD) a copy of this Resolution for reference and appropriate action.
