ADOPTING AND CONFIRMING THE TECHNICAL WORKING GROUP (TWG) POST-QUALIFICATION AND DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING THE SAME TO THE HOPE TO AWARD THE CONTACT FOR THE PROCUREMENT OF BRAND NEW DILG RO1 ICT EQUIPMENT/ RESOURCES AND OFFICE PRODUCTIVITY SOFTWARE TO SUPPORT DAY-TO-DAY OPERATIONS UNDER THE OFFICE PRODUCTIVITY PROJECT

WHEREAS, the Bids and Awards Committee (BAC) of the DILG Regional Office 1 adheres to the principles of transparency and competitiveness as mandated under RA 9184 otherwise known as "Government Procurement Reform Act" and its Revised Implementing Rules and Regulations;

WHEREAS, the Procuring Entity intends to procure Brand New DILG RO1 ICT Equipment/ Resources and office productivity software to support day-to-day operations on a *lot basis* with an Approved Budget for the Contract (ABC) of Seven Million Four Hundred Sixty Thousand Pesos (Php 7,460,000.00);

WHEREAS, the procurement was posted at PhilGEPS Portal, DILG R1 website and conspicuous place on June 07, 2024 to July 03, 2024 at 2:00PM;

WHEREAS, on July 03, 2024 @ 02:01 PM, the scheduled opening and evaluation of bids, there were five (5) prospective bidders who submitted their bid proposals namely, IT Avenue General Merchandize, JOEBZ Computer Sales and Services, Perfect Solution Consumer Goods Trading, RC2 Technologies Operations, and MSN Consumer Goods Trading;

WHEREAS, BAC Resolution No. 2024-41 declared MSN Consumer Goods Trading as the Lowest Calculated Bidder (LCB) but was Post-Disqualified thru BAC Resolution No. 2024-45 due to failure to comply with, and be responsive to, the technical specifications prescribed in the Bidding Documents;

WHEREAS, BAC Resolution No. 2024-45 also subjected JOEBZ Computer Sales and Services (2nd LCB) with a bid amounting to Six Million Nine Hundred Twenty-Two Thousand Eighty Pesos (Php 6,922,080.00) to Post Qualification scheduled on July 10, 2024, at 10:00 AM via Zoom Conference;

WHEREAS, as a result of the careful deliberation of the TWG Post Qualification Report by the BAC Members on July 10, 2024, 2:00 PM via Hybrid Conference, it was determined that JOEBZ Computer Sales and Services (2nd LCB) is compliant with all the Eligibility Requirements and is responsive to all the technical specifications prescribed in the Bidding Document. Attached is the Post Qualification Report for reference.;

NOW THEREFORE, WE, the BAC Members, RESOLVE, as it is hereby RESOLVED:

- a) To declare JOEBZ Computer Sales and Services as the Lowest Calculated and Responsive Bidder (LCRB) with a bid amount of Six Million Nine Hundred Twenty-Two Thousand Eighty Pesos (Php 6,922,080.00);
- b) To recommend to the HoPE the approval of this recommendation and to award the Contract.

CONTRACT OF AGREEMENT

Bid form, including all the documents /statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

iii. Performance Security;

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that additional contract documents or</u> <u>information prescribed by the GPPB that are subsequently</u> <u>required for submission after the contract execution, such as</u> <u>the Notice to Proceed, Variation Orders, and Warranty</u> <u>Security, shall likewise form part of the Contract.</u>
- 3. In consideration for the sum of SIX MILLION NINE HUNDRED TWENTY TWO THOUSAND AND EIGHTY PESOS ONLY (Php6,922,080.00) JOEBZ COMPUTER SALES AND SERVICES, agrees to deliver the BRAND NEW DILG ROI ICT EQUIPMENTS/RESOURCES AND OFFICE PRODUCTIVITY SOFTWARE TO SUPPORT DAY-TO-DAY OPERATIONS for DILG Region 1 in accordance with his/her/its Bid.
- 4. The **DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


