Know all men by these presents:

This **CONTRACT** is entered into by and between **SAN JUAN RESORT DEVELOPMENT AND MANAGEMENT CORPORATION** represented by **MS. NELIA SANCHEZ, Designated Representative** with business address at Barangay Ili Sur, San Juan, La Union, herein referred to as the **FIRST PARTY**;

THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT REGION 1, represented by DIR. JAMES F. FADRILAN, CESO III, Regional Director, with office address at Sevilla, City of San Fernando, La Union, herein referred to as the SECOND PARTY.

Under the following terms and conditions:

- That the FIRST PARTY will provide meals, snacks and accommodation for the SECOND PARTY'S participants for the conduct of 2019 Seal of Good Local Governance (SGLG) on April 10, 2019.
- 2.) That both parties agreed that the guaranteed number of participants is **Fifty Three (53)**.
